SUBJECT: Amending a resolution, which authorized the County of Westchester to enter into an agreement with the YWCA of White Plains and Central Westchester to provide child care in the Richard A. Daronco Court House in White Plains, in order to modify the term and not-to-exceed amount of the agreement

By a resolution approved on March 3, 2016, your Honorable Board authorized the County of Westchester, acting by and through its Office for Women, (the "County") to enter into an agreement with the YWCA of White Plains and Central Westchester, by and through its Children's Center, (the "YWCA") pursuant to which the YWCA would provide child care in the Richard A. Daronco Court House in White Plains, for a term from January 1, 2016 through December 31, 2018, for a total amount not-to-exceed \$148,011, to be paid quarterly pursuant to an approved budget, with the funding amount per year not-to-exceed \$49,337 (the "March 3rd Resolution").

The County now respectfully requests that your Honorable Board amend the March 3rd Resolution by modifying the term of the Agreement to January 1, 2016 through December 31, 2016 and by reducing the total not-to-exceed amount accordingly by \$98,674, from \$148,011 to \$49,337.

Except as described above, all other terms and conditions of the March 3rd Resolution will remain the same.

Attached for your consideration is a proposed resolution.

RESOLUTION

Upon a communication from the Director of the Office for Women, be it hereby

RESOLVED, that the resolution approved on March 3, 2016, which authorized the County of Westchester, acting by and through its Office for Women, (the "County") to enter into an agreement with the YWCA of White Plains and Central Westchester, by and through its Children's Center, (the "YWCA"), pursuant to which the YWCA would provide child care in the Richard A. Daronco Court House in White Plains, for a term from January 1, 2016 through December 31, 2018, for a total amount not-to-exceed \$148,011, to be paid quarterly pursuant to an approved budget, with the funding amount per year not-to-exceed \$49,337 (the "March 3rd Resolution"), is hereby amended to modify the term of the agreement to January 1, 2016 through December 31, 2016 and to reduce the total not-to-exceed amount accordingly by \$98,674, from \$148,011 to \$49,337; and be it further
