Re: **RESOLUTION AUTHORIZING THE COUNTY OF WESTCHESTER TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES TO ACCEPT A GRANT IN THE AMOUNT OF \$66,750 IN FEDERAL FUNDS AND TO CONTRIBUTE \$548,687 IN COUNTY MATCHING FUNDS FOR THE DISTRICT ATTORNEY'S OFFICE TO OPERATE THE STOP VIOLENCE AGAINST WOMEN COLLABORATIVE PROGRAM FOR THE PERIOD FROM JANUARY 1, 2016 THROUGH DECEMBER 31, 2016**

Authority is sought from this Honorable Board to enter into an agreement with the New York State Division of Criminal Justice Services ("NYSDCJS") to accept a grant in the amount of \$66,750 in federal funds and to contribute \$548,687 in County matching funds for the District Attorney's Office to operate the STOP Violence Against Women Collaborative Program for the period from January 1, 2016 through December 31, 2016 to provide various support services to victims of domestic violence, stalking and sexual assault.

The overall goal of the STOP Violence Against Women Collaborative Program is to reduce violence against women, female high school and college students, as well as women with other language, cultural and social barriers. Additionally, the project will strengthen and heighten the safety and security of women by providing direct support services to victims as well as training to police agencies and the community. The goals and objectives will be monitored by the District Attorney's Office and quarterly progress reports will be submitted to NYSDCJS for their review and approval.

As this agreement does not involve the procurement of goods or services the provisions of the Westchester County Procurement Policy do not apply
