On April 20, 2016, five (5) bids were received and opened for Contract No. 14-502 for Sprain Lift Pumping Station Access Driveway, Bronx Valley Sewer District, Greenburgh, New York.

The bids were reviewed by the Department and it was determined that Abbott & Price, Inc. submitted the low bid in the amount of \$389,414.00.

The low bidder has been investigated and it has been found that Abbott & Price, Inc.:

The objective of this contract is to provide life-safety site improvements at the Sprain Lift Pumping Station by providing an access driveway to the Sprain Lift Pumping Station off Jackson Avenue, instead of from the left lane of the northbound Sprain Brook Parkway. Present ingress and egress for vehicles is very dangerous off the Sprain Brook Parkway and the new driveway will provide safety for the traveling public, as well as County maintenance personnel.

This contract is in the public's best interest because it will allow for safe access to the Sprain Lift Pumping Station for County maintenance personnel to perform required maintenance, inspection and repairs to ensure that the operation of the Sprain Lift Pumping Station is safe and environmentally compliant, thereby enhancing the health and general welfare of the residents of Westchester County.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 14-502 be awarded to Abbott & Price, Inc. in the amount of \$389,414.00.
