VRH canvassed two (2) MWOB firms for Painting. One (1) firm did not respond to VRH's inquiry; and one (1) firm's quoted price exceeds the budgeted amount for the type of work being requested.

VRH canvassed one (1) MWOB firm for Drywall and Ceilings. The firm responded as not interested.

Absolute Flooring of Yorktown will be installing Carpet, Resilient Flooring and Tile; A. Liss & Co. will be furnishing and installing Toilet Accessories, Toilet Partitions and Lockers; Bamco Inc. will be installing Metal Wall Panels; and Proformance Systems Inc. will be furnishing and installing Operable Partition and Overhead Coiling Doors. Please note that the Westchester County Minority/Women's Owned database was reviewed and there are no qualified MWOB firms currently registered to perform this type of specialized work.

The listed Subcontractors have been investigated, and the Department recommends approval.
