RE: Resolution authorizing Westchester County, acting by and through its Department of Public Safety ("DPS"), to retroactively enter into a Memorandum of Agreement ("the Agreement") with the United States Department of State, Bureau of Diplomatic Security ("BDS"). The Purpose of the Agreement is to delineate the responsibilities of the parties for the protection of foreign missions and officials pursuant to the Foreign Missions Act of 1982. The Agreement will retroactively commence on October 1, 2011 and will continue indefinitely. Either party may terminate the Agreement upon 90 days' notice to the other.

Authority is hereby respectfully requested for Westchester County, acting by and through its Department of Public Safety ("DPS") to retroactively enter into a Memorandum of Agreement ("the Agreement") with the United States Department of State, Bureau of Diplomatic Security ("BDS") is to delineate the responsibilities of the parties for the protection of foreign missions and officials pursuant to the Foreign Missions Act of 1982. The Agreement will retroactively commence on October 1, 2011 and will continue indefinitely. Either party may terminate the Agreement upon 90 days' notice to the other.

The public purpose of the agreement is for DPS, upon specific request from BDS, to provide extraordinary protective services for visiting or resident foreign officials, official facilities and international organizations responsive to the existence of a threat of violence or other circumstance.

The goals and objectives of this program are for DPS, upon specific request of BDS or the United States Secret Service, to provide protection operations in support of visiting and resident foreign officials and their facilities located in Westchester County.

The goals and objectives of this program are for BDS to make reimbursements to DPS for expenses already incurred in connection with these services from October 1, 2011 through September 30, 2015 as well as for expenses to be incurred in the future in accordance with DPS' schedule of wages and rates, subject to Congressional appropriations for this purpose and applicable federal laws and regulations.

This program will be tracked and monitored DPS sworn members and staff.

Wherefore, authority is respectfully sought for the County of Westchester to enter into this Agreement.

RESOLUTION

Upon a communication from the Commissioner-Sheriff, Department of Public Safety, be it hereby

RESOLVED, that authority is hereby granted to retroactively enter into a Memorandum of Agreement (“the Agreement”) between the United States Department of State, Bureau of Diplomatic Security (“BDS”) and Westchester County, acting by and through its Department of Public Safety (“DPS”) to delineate the responsibilities of the parties for the protection of foreign missions and officials pursuant to the Foreign Missions Act of 1982, and be it further

RESOLVED, that the Agreement will retroactively commence on October 1, 2011 for the purpose of making reimbursements to DPS for expenses already incurred in connection with these services from October 1, 2011 through September 30, 2015, and be it further

RESOLVED, that the Agreement will continue indefinitely, unless and until either party terminates upon 90 days’ notice to the other, for the purpose of making reimbursements to DPS expenses to be incurred in the future in accordance with DPS’ schedule of wages and rates, subject to Congressional appropriations for this purpose and applicable federal laws and regulations., and be it further

RESOLVED, that the County Executive, or his authorized designee, be, and hereby is, authorized to enter into and execute this Agreement for the County of Westchester.
