On June 22, 2016, four (4) bids were received and opened for Contract No. 15-501 for Central Electrical Distribution Facility Addition, Valhalla Campus, Valhalla, New York.

The bids were reviewed by the Department and it was determined that Vinco Builders LLC submitted the low bid in the amount of \$382,200.00, and has proposed the utilization of the following subcontractor: Consolidated Hudson Electric Corp (Electrical Work), 64 Main Street, Irvington, New York 10533.

The low bidder has been investigated and it has been found that Vinco Builders LLC:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to enlarge the facility to increase the clearance around the electrical switchgear.
