On August 10, 2016, three (3) bids were received and opened for Contract No. 13-525 for Roadside Stabilization and Miscellaneous Improvements, North Street (C.R. #30), City of White Plains, New York.

The bids were reviewed by the Department and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$488,980.00.

The low bidder has been investigated and it has been found that ELQ Industries, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard roadside conditions.
