On May 25, 2016, nine (9) bids were received and opened for Contract No. 16-503 for Rehabilitate Tower Road, Westchester County Airport, Towns of Harrison and North Castle and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that Laura Li Industries, LLC submitted the low bid in the amount of \$544,197.50.

The low bidder has been investigated and it has been found that Laura Li Industries, LLC:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

Funds for this project are available in the:

- Capital Budget  
 Non-Recurring Budget  
 Operating Budget

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Tower Road meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this entire contract will be made from Federal Aviation Administration Funds, New York State Funds and the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

It is my recommendation that Contract No. 16-503 be awarded to Laura Li Industries, LLC in the amount of \$544,197.50.
