On November 9, 2016, two (2) bids were received and opened for Contract No. 07-549-Rev. for Pool Modernization, Sprain Ridge Park, Yonkers, New York.

Two (2) contractors submitted bids for this project. The project was advertised on the Empire State Purchasing Group website, in addition to the Journal News (Westchester-Putnam Edition), and was viewed by thirty one (31) entities on the Empire State Purchasing Group website. In addition, e-mails were sent to those thirty one (31) entities and to an additional one thousand and seventeen (1,017) suppliers and contractors.

The bids were reviewed by the Department and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$7,771,000.00.

The low bidder has been investigated and it has been found that ELQ Industries, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to repair and upgrade the existing pool facilities so that they can be reopened for public use.

This contract is in the public's best interest because it will provide water park facilities meeting current State and Health Department codes and standards. The project will provide energy savings by the use of state-of-the-art water filtration systems.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 07-549-Rev. be awarded to ELQ Industries, Inc. in the amount of \$7,771,000.00.
