Re: **Resolution authorizing amendment of a resolution which authorized the County of Westchester to exercise its third option to renew an Agreement with On Assignment Staffing Services, Inc. (the "Contractor"), for the provision of temporary laboratory personnel on an as-needed basis, at a total cost to the County not to exceed One Hundred Fifty-Four Thousand One Hundred Twenty-Five (\$154,125) Dollars, for this one (1) year extension period, commencing on January 1, 2017 and terminating on December 31, 2017, to reflect the Contractor's name change from "On Assignment Staffing Services, Inc." to "Apex Life Sciences, LLC."**

By resolution approved on February 12, 2014, your Honorable Board authorized the County of Westchester (the "County") acting by and through its Department of Labs and Research (the "Department") to enter into an agreement (the "Agreement") with the Contractor pursuant to which the Contractor provided temporary laboratory personnel on an as-needed basis, at a total annual cost to the County not to exceed \$197,775.00 for the one (1) year period commencing on January 1, 2014 and terminating on December 31, 2014, with options exercisable in the County's sole discretion to renew the Agreement for four (4) additional one (1) year periods (the "Agreement"). The Agreement was subsequently executed.

Thereafter, by resolution approved on January 8, 2015, your Honorable Board authorized the County to exercise its first option to renew the Agreement with On Assignment for the provision of temporary lab personnel on an as-needed basis, at a total annual cost to the County not to exceed \$214,325.00 for the one (1) year extension period commencing on January 1, 2015 and terminating December 31, 2015 (the "First Option to Renew"). The First Option to Renew was duly executed.

Thereafter, by resolution approved on December 17, 2015, your Honorable Board authorized the County to exercise its second option to renew the Agreement with On Assignment for the provision of temporary lab personnel on an as-needed basis, at a total annual cost to the

County not to exceed \$149,025.00, for the one (1) year extension period commencing on January 1, 2016 and terminating December 31, 2016 (the "Second Option to Renew"). The Second Option to Renew was duly executed.

The County, acting by and through the Department, is then received authority from your Honorable Board on November 10, 2016 to exercise its third option to renew the Agreement for an additional one (1) year term at a total amount not to exceed One Hundred Fifty-Four Thousand One Hundred Twenty-Five (\$154,125) Dollars, for this one (1) year option period from January 1, 2017 through December 31, 2017. After receiving such authority, the Department was advised that the Contractor had changed its name to Apex Life Sciences, LLC. Therefore, Authority is now requested for the Department to enter into the third renewal term with Apex Life Sciences LLC.

Except as specifically amended hereby, all remaining terms and conditions of the Agreement, as previously amended, shall remain the same.

The goal and objective of the Agreement is to provide the residents of Westchester County with the most qualified temporary lab personnel to conduct forensic and public health analysis. The value and importance of these services are in the best interest of the County in terms of ensuring continued public health and safety. The goal and objective will be tracked and monitored by each division which maintains attendance records and the proficiency of the temporary personnel. These personnel are paid on an hourly basis for which the County is billed weekly. Division heads approve weekly timesheets which are forwarded to the vendor and returned with the weekly billing.

The Contractor has always been very responsive to the Department's needs and has historically provided the Department with excellent service at a good price. Accordingly, I recommend that your Honorable Board approve the attached Resolution authorizing the County to exercise its option to renew the Agreement with the Contractor.

RESOLUTION

Upon a communication from the Medical Examiner/Pathologist, be it hereby:

RESOLVED, that the resolution of the Board of Acquisition and Contract No. 52985 dated November 10, 2016 which authorized the County to exercise its third option to renew an agreement (the "Agreement") with On Assignment Staffing Services, Inc. (the "Contractor") for the provision of temporary lab personnel on an as-needed basis, at a total annual cost to the County not to exceed \$175,625 for a one (1) year extension period commencing on January 1, 2017 and terminating on December 31, 2017 is hereby amended to reflect the contractor's new name, "**Apex Life Sciences, LLC**," and be it further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the Agreement, as previously amended, shall remain the same; and be it further

RESOLVED, that the Agreement is subject to County appropriations; and be it further

RESOLVED, that the Agreement is also subject to further financial analysis of the impact of any New York State Budget, (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed budget of the State of New York and/or the adoption of a State Budget or any amendments thereto and after the County has a reasonable period of time to conduct an analysis of the impacts of any such budget(s) on County finances, to terminate the agreement authorized herein or to renegotiate the amount and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive, or his duly authorized designee, is hereby authorized to execute such documents and take such actions as may be necessary and appropriate to effectuate the purposes hereof.
