SUBJECT: Authority for the County of Westchester to enter into an agreement with the United States Department of Agriculture for wildlife management at the Westchester County Airport for a three (3) year period from May 1, 2017 to April 30, 2020. (Agreement No. WCA 17003)

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the United States Department of Agriculture (the "USDA") for wildlife management at the Westchester County Airport whereby the USDA will provide services to identify potential hazards to aircraft and assist in reducing bird and mammal strikes by aircraft at the Airport. The term of the agreement will be for a three (3) year period commencing on May 1, 2017 and continuing through April 30, 2020. The USDA will be paid a fee not to exceed \$511,122.00 over the three (3) year period, subject to appropriation and payable as follows: not to exceed \$165,370.00 for year one (1), payable at the hourly rate of \$79.20; not to exceed \$170,318.00 for year two (2), payable at the hourly rate of \$81.57; and not to exceed \$175,434.00 in year three (3), payable at the hourly rate of \$84.02.

This agreement will benefit the traveling public by maintaining the airfield in a safe manner for arriving and departing aircraft. The goals and objectives of this agreement will be for the USDA to identify wildlife that pose a hazard to aircraft and assist the Airport with limiting potential nesting areas. Airport Operations will monitor the agreement, and the USDA will only be paid upon written invoices for the services rendered.

Payment for this agreement will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

This agreement is exempt from the Westchester County Procurement Policy pursuant to Section 3(b)(iii) thereof.

I recommend approval of the attached proposed Resolution.

RESOLUTION

Upon a communication from the Commissioner of Public Works and Transportation, it is hereby

RESOLVED, that the County of Westchester (the "County") is authorized to enter into an agreement with the United States Department of Agriculture (the "USDA") for wildlife management services at the Westchester County Airport for a three (3) year period commencing on May 1, 2017 and continuing through April 30, 2020; and be it further

RESOLVED, that the USDA will be paid a fee not to exceed \$511,122.00 over the three (3) year period, subject to appropriation and payable as follows: not to exceed \$165,370.00 for year one (1), payable at the hourly rate of \$79.20; not to exceed \$170,318.00 for year two (2), payable at the hourly rate of \$81.57; and not to exceed \$175,434.00 in year three (3), payable at the hourly rate of \$84.02; and be it further

RESOLVED, that the County Executive, or his duly appointed designee be, and hereby is, authorized to execute such documents and take such actions as may be necessary and appropriate to to effect the purposes hereof.
