The 2017 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all labor, material and equipment required to rehabilitate the existing structure including excavation and shaping of the existing stream channel, repairing and sealing interior concrete surfaces and replacement of existing bridge rail and approach guide rail. Project also includes resurfacing approximately 400 linear feet of approach roadway.

The objective of this contract is to repair substandard structural elements of the Bowman Avenue Bridge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Bowman Avenue Bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
