On March 22, 2017, three (3) bids were received and opened for Contract No. EF-1702, a contract for Internal Inspection and Cleaning of the Blind Brook Trunk Sewer Section K-1, Blind Brook Sewer District, City of Rye, Westchester County, New York for a term beginning on or about May 1, 2017 and ending on December 29, 2017.

The bids were reviewed by the Department and determined that National Water Main Cleaning Co. submitted the low bid in the amount of \$57,625.00.

The goal and/or objective of this contract is to provide an internal inspection of the referenced sewers to inspect for potential structural and/ or operational defects and problems that may exist with the sewer pipe and related appurtenances. The work will be performed as part of the self assessment provision of the Federal Capacity, Management, Operations, and Maintenance (CMOM) program. This contract is deemed to fulfill a public purpose as the services provided under this Contract promotes the public health and welfare by insuring proper operation of the County's Trunk Sewer System and the prevention and/or elimination of any sewage overflows. The response and work are monitored by representatives of the department throughout the contract to make sure all applicable regulations, safety precautions and codes regarding the protection of persons and property are adhered to and that a cost-effective project is the end product.

It is recommended that Contract No. EF-1702 be awarded to the lowest responsible bidder, National Water Main Cleaning Co. in the amount of \$57,625.00 subject to appropriations.

RESOLVED, That Contract No. EF-1702 for a contract for Internal Inspection and Cleaning of the Blind Brook Trunk Sewer Section K-1, Blind Brook Sewer District, City of Rye, Westchester County, New York, is awarded to the lowest responsible bidder, National Water Main Cleaning Co., 1806 Newark Turnpike, Kearny, NJ, 07032-4314, in the amount \$57,625.00 for a term beginning on or about May 1, 2017 and ending on December 29, 2017; and be it further

RESOLVED, That this Agreement is subject to County appropriations; and be it further

RESOLVED, That this Agreement subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, That the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
