RE: **Resolution authorizing an agreement with the State University of New York (“SUNY”) pursuant to which SUNY will provide Westchester County, acting by and through Westchester Community College (the “College”), with funding for the operation of its Educational Opportunity Program for a five-year term from September 1, 2016 through August 31, 2021.**

The mission of the Westchester Community College Educational Opportunity Program (“EOP”) is to assist first generation college students who come from academically and economically disadvantaged backgrounds in successfully graduating from the College. EOP offers students the academic, personal and financial support needed to help attain their educational and professional objectives. The program also supports personal, intellectual, and cultural growth by promoting a range of services designed to foster a student’s individual development.

Attached is a resolution that would authorize the College to enter into a five year agreement with the State University of New York (“SUNY”) pursuant to which SUNY will provide Westchester County, acting by and through Westchester Community College (the “College”), with funding for the operation of the College’s Educational Opportunity Program for a five-year term from September 1, 2016 through August 31, 2021. The total amount payable to the College for the five-year term shall be approximately \$1,071,027.

The goals and objectives of this Agreement are to deliver support services to eligible students, which leads to enhanced employment opportunities, access to further education and personal growth. This agreement is in the best interests of the County because it will assist in educating first generation college students. The College will track and monitor the school’s progress in achieving the stated goals and objectives.
