On June 21, 2017, six (6) bids were received and opened for Contract No. 15-520 for Rehabilitation of Halstead Avenue Bridge over Mamaroneck River (BIN 3348290), Village of Mamaroneck, New York.

The bids were reviewed by the Department and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$678,633.27.

The low bidder has been investigated and it has been found that ELQ Industries, Inc.:

- Performed satisfactory work in the past for the County
 Past experience has been investigated and found satisfactory

The objective of this contract is to repair substandard structural elements of the Halstead Avenue Bridge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Halstead Avenue Bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 15-520 be awarded to ELQ Industries, Inc. in the amount of \$678,633.27.
