Authority is requested to advertise for the purpose of soliciting competitive bids for a contract to provide Security Escort Services for DSS Child Welfare Staff for a three-year period with the County having an option to extend the contract for three (3) additional one-year periods. The required legal notice will appear in the Journal News (Westchester-Putnam Edition).

The work under this contract will consist of all necessary labor, materials and equipment to provide Security Escorts to accompany DSS Child Welfare staff, including Child Protective, Preventive Service and Foster Care, out of the office to make contact with DSS customers in the community, as needed,

Performance security in the form of cash, certified check, irrevocable letter of credit, or performance and payment bond in the amount of 30% of the total annual contract will be required.

Upon a communication from the Commissioner of the Department of Social Services, be it hereby

**RESOLVED**, that the Commissioner of Social Services is hereby authorized to solicit bids by public advertisement for Contract Number DSS600-18 for the provision of Security Escort Services for DSS Child Welfare Staff for a three-year period with the County having an option to extend the contract for three (3) additional one-year periods; and be it further

**RESOLVED**, that adequate and sufficient security for the full and faithful performance of this contract shall be deemed to be receipt of cash, certified check, irrevocable letter of credit, or performance and payment bond in the amount of 30% of the total annual contract amount and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the US Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

**RESOLVED**, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women – Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further

**RESOLVED**, that such advertisement shall appear in The Journal News (Westchester-Putnam Edition).
