RE: Authority for the County of Westchester to enter into a Grant Agreement with the Federal Transit Administration ("FTA") for \$8,000,000.00 in Federal Transit Capital Assistance (Grant Agreement NY-2017-019-00).

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the Federal Transit Administration ("FTA") for transit capital assistance for a grant totaling \$10,000,000.00 as follows:

Federal Funds	80%	\$ 8,000,000.00
Local Funds	20%	<u>\$ 2,000,000.00</u>
Total		\$10,000,000.00

Funds received from this grant will be utilized as follows:

Preventive Maintenance: (\$8,000,000.00 Federal)

These funds will be used to cover the cost of preventive maintenance for Westchester County's Bee-Line buses and related facilities. This includes general maintenance of the buses and garage facilities. Funds are for labor only and no materials will be purchased.

The goal of this project is to maintain buses and bus facilities that are vital to the operation of the Bee-Line Bus System.

The receipt of reimbursement funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.

RESOLUTION

Upon a communication from the Commissioner of Public Works and Transportation, be it hereby:

RESOLVED, that the County of Westchester (the "County") is hereby authorized to enter into a grant agreement with the Federal Transit Administration ("FTA") for a grant totaling \$10,000,000.00 (80% Federal \$8,000,000.00; 20% Local \$2,000,000.00) to be used for Preventive Maintenance; and be it further

RESOLVED, that the County Executive or his authorized designee is authorized to file any other document required by the United States Department of Transportation effectuating the purpose of Title VI of the Civil Rights Act of 1964 and to set forth and execute affirmative minority business policies in connection with the project; and be it further

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized to execute any and all documents necessary and appropriate to effectuate the purposes hereof.
