Re: **Resolution Authorizing the County of Westchester to enter into a Film Permit with 20th Century Fox Film Corporation to authorize filming at the Richard A. Daronco Courthouse and the Michaelian Office Building from July 8, 2017 through July 9, 2017 for a permit fee of \$27,049.50.**

Authority is requested for the County of Westchester, by and through its Office of Tourism & Film, to enter into a Film Permit with 20th Century Fox Film Corporation (“20th Century Fox”) in order for 20th Century Fox to utilize locations at the Richard A. Daronco Courthouse, the Michaelian Office Building, and the Board of Election Parking Lot, White Plains, New York to film scenes for a film entitled “Nor’easter” from July 8, 2017 through July 8, 2017. This request is being made because the film permit which authorizes a fee of \$27,049.50, to be paid to the County, requires your Honorable Board’s approval. This film permit will result in revenue for the County and will also promote the County and provide revenue for local businesses.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board’s approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with 20th Century Fox is attached for your Honorable Board’s approval.
