SUBJECT: Authorization to amend Agreement No. 15-938 with Rudolph C. Petruccelli
d/b/a Petruccelli Engineering (the "Consultant") to change the name of the Consultant to
Petruccelli Engineering, D.P.C.

Pursuant to a Resolution approved on July 9, 2015, the County of Westchester (the "County") entered into Agreement No. 15-938 with Rudolph C. Petruccelli d/b/a Petruccelli Engineering (the "Consultant"), 600 North Broadway, Suite 215, White Plains, New York 10603, for Engineering Design Services in connection with the Rehabilitation of Halstead Avenue, G.R. #80A, Town of Harrison, New York (the "Agreement") for the term July 15, 2015 through December 31, 2019, in the amount of \$88,405.00.

Upon notification from the Consultant, the County was informed that effective July 14, 2017, the company name of the Consultant has been changed to Petruccelli Engineering, D.P.C. We are advised that this is a name change only and the same office contact personnel will be used to perform the work thus guaranteeing continuity throughout the Agreement. Except as specifically amended hereby, all other terms and conditions of Agreement No. 15-938 will remain the same.

Therefore, approval is requested to amend Agreement No. 15-938 to reflect the Consultant's new name.

The objective of this name change is in the County's best interest as it will provide for uninterrupted consulting services pursuant to Agreement No. 15-938 for the Department project contained therein.

The Department shall continue to track scheduling and accomplishments by the Consultant and perform on-site inspections to ensure the successful completion of this project.

RESOLVED, that the County of Westchester (the "County"), acting by and through its Department of Public Works and Transportation (the "Department"), is hereby authorized to amend Agreement No. 15-938 with Rudolph C. Petruccelli d/b/a Petruccelli Engineering (the "Consultant"), 600 North Broadway, Suite 215, White Plains, New York 10603, for Engineering Design Services in connection with the Rehabilitation of Halstead Avenue, C.R. #80A, Town of Harrison, New York to change the name of the Consultant from Rudolph C. Petruccelli d/b/a Petruccelli Engineering to Petruccelli Engineering, D.P.C., effective retroactive to July 14, 2017; and be it further
