RE: Approval to subcontract a portion of the routes covered under both WCDH contract E/T 533 – Regional Transportation Needs, Northern Regional Zone and WCDH contract E/T 537 – Westchester County Chapter NYSARC/CSED program locations in Katonah, Mt. Kisco & Yorktown with Acme Bus Corp. to All County Bus, LLC, effective September 13, 2017

The approval of All County Bus, LLC as a Subcontractor is being requested by Acme Bus Corp. (“Operator”) to provide transportation services for a portion of the routes covered under both WCDH contract E/T 533 – Regional Transportation Needs, Northern Regional Zone and WCDH contract E/T 537 – Westchester County Chapter NYSARC/CSED program locations in Katonah, Mt. Kisco & Yorktown, effective September 13, 2017.

The Westchester County Department of Health (“WCDH”) was recently notified by the Operator that due to a driver shortage it would be unable to provide services to all routes covered by the above referenced contracts, and that it would be unable to procure the necessary resources in time to prevent future disruption in services.

The Subcontractor has been investigated and the WCDH recommends approval.

As your Honorable Board is aware, Westchester County is mandated by Section 4410 of the New York State Education Law, and its implementing regulations in 8 NYCRR Part 200, and by Title IIA, Article 25 of the New York State Public Health Law, all as may be amended from time to time, to pay for education and transportation of children with special needs.

Therefore, in order to minimize and prevent future disruption in the transportation services to the special needs programs provided by Regional Transportation Needs, Northern Regional Zone and Westchester County Chapter NYSARC/CSED program locations in Katonah, Mt. Kisco & Yorktown, the approval of All County Bus, LLC as a Subcontractor is being requested by the Operator to provide transportation services for a portion of the routes covered under both WCDH contracts E/T 533 and WCDH E/T 537, effective September 13, 2017.
