On August 30, 2017, eight (8) bids were received and opened for Contract No. 17-511 for Parking Lot Improvements and New Roadway Pavement, Sprout Brook Residue Disposal Facility, Town of Cortlandt, New York.

The bids were reviewed by the Department and it was determined that Montesano Brothers, Inc. submitted the low bid in the amount of \$268,160.00.

The low bidder has been investigated and it has been found that Montesano Brothers, Inc.:

- Performed satisfactory work in the past for the County

The objective of this contract is to replace substandard areas of asphalt paving.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
