Re: **Resolution Authorizing the County of Westchester to enter into a Film Permit with NBC Universal Television to authorize filming at the Westchester County Airport on December 6, 2017 for an estimated permit fee of \$34,500 plus County personnel overtime costs.**

Authority is requested for the County of Westchester, by and through its Office of Tourism & Film, to enter into a Film Permit with NBC Universal Television in order for them to utilize locations at Westchester County Airport to film scenes for a television series entitled "Law and Order: SVU" on December 6, 2017. This request is being made because the film permit authorizes a fee of \$34,500, plus overtime costs for County personnel, to be paid to the County, and requires your Honorable Board's approval. This film permit will result in revenue for the County and will also promote the County and provide revenue for local businesses.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board's approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with NBC Universal Television is attached for your Honorable Board's approval.
