RE: **Authority to enter into an agreement with Ralph Butler, P.E. for consulting services related to the County's capital program for a term commencing on February 19, 2018 and continuing through December 31, 2018 in an amount not-to-exceed \$30,000.00, payable at an hourly rate of \$80.00.**

Authority is requested for the County of Westchester (the "County") to enter into an agreement with Ralph Butler, P.E. for consulting services related to the County's capital program for a term commencing on February 19, 2018 and continuing through December 31, 2018 in an amount not-to-exceed Thirty Thousand (\$30,000.00) Dollars, payable at an hourly rate of Eighty (\$80.00) Dollars.

Pursuant to the terms of the agreement, Mr. Butler will perform various services related to the County's capital program, including but not limited to: review of 1920s, priority rankings, Planning Board report and status report of the existing program; review all related documents to support the capital program, such as the departments' operating budgets, Facility Asset Management reports and budget estimates; prepare written reports, as required; provide Project Performance Measures report with each requisition submission.

Authority to exempt this Agreement from the requirements of the Westchester County Procurement Policy and Procedures pursuant to Section 3(a)xxi thereof, has been granted by your Honorable Board in accordance with a separate resolution of even date herewith.

This Agreement will serve a public purpose by using the skills and institutional knowledge of Mr. Butler, the County's former Commissioner of Public Works, to provide guidance with regard to the County's capital program.

Authority for the County to enter into this Agreement for the purposes as herein described is most respectfully requested.

RESOLUTION

Upon a communication from the Deputy County Executive, be it hereby

RESOLVED, that the County of Westchester (“County”) is authorized to enter into an agreement with Ralph Butler, P.E. for consulting services related to the County’s capital program for a term commencing on February 19, 2018 and continuing through December 31, 2018 in an amount not-to-exceed Thirty Thousand (\$30,000.00) Dollars, payable at an hourly rate of Eighty (\$80.00) Dollars; and be it further

RESOLVED, that this Agreement shall be subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the “State Budget”) proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his duly authorized designee is authorized to execute said agreement and all documents necessary to effectuate the purposes hereof
