Re: **Resolution authorizing the County of Westchester to enter into a License Agreement with the Town of North Castle for continued use of vacant land known as several parcels of Sheet 28, Bronx River Parkway for the operation of a parking lot for the period April 1, 2018 through March 31, 2019 at a license fee of \$33,289.**

Authority is requested for the County to enter into a License Agreement with the Town of North Castle, 15 Bedford Road, Armonk, New York (hereinafter the "Licensee") for the continued use of vacant land known as several parcels of Sheet 28, Bronx River Parkway for a term commencing April 1, 2018 and continuing through March 31, 2019. In consideration for the privilege of operating this License, the Licensee agrees to pay the County a license fee of Thirty Three Thousand Two Hundred Eighty Nine (\$33,289) Dollars.

The area is located on Fisher Lane near the North White Plains Railroad Station and is operated as a commuter parking facility for the residents of the Town.

The public purpose of this agreement is that it encourages the public to use mass transportation which benefits the environment. The ultimate goal of the agreement is to provide revenue to the County. This agreement allows more commuters to use mass transit rather than using personal vehicles which benefits the County by reducing air pollution and traffic in addition to providing revenue to the County.

The program will be tracked and monitored by site inspections.

This agreement is exempt from the Westchester County procurement policy pursuant to Section 3 (b), thereof.

Accordingly, your favorable action on the annexed Resolution is most respectfully urged and recommended.

**RESOLVED**, that the County Executive or his duly authorized designee is hereby authorized to take such action and execute such documents as may be necessary and proper to effect the purposes hereof.
