Re: Resolution authorizing the County of Westchester, acting by and through Westchester Community College, to enter into an agreement with Bargaining Associates, LLC for the provision of consulting services to Westchester Community College in connection with labor negotiations and related matters for the term September 1, 2017 through August 31, 2018 for an amount not to exceed \$78,000 payable at an hourly rate of \$200 pursuant to an approved budget

Authority is requested to enter into an agreement with Bargaining Associates, LLC for the provision of consulting services to Westchester Community College in connection with labor negotiations and related ongoing contractual matters including, without limitation, arbitrations, grievances, unfair labor practices charges, improper practice charges and labor management committee meetings. The term of the agreement will be September 1, 2017 through August 31, 2018 for an amount not to exceed \$78,000 payable at an hourly rate of \$200 pursuant to an approved budget.

A separate resolution seeking the exemption of this proposed agreement in accordance with Section 3 (a) xxi of the County's Procurement Policy has been submitted to your Honorable Board for approval.

Given Mr. Wittenberg's vast experience and familiarity with County labor practices and procedures, it would serve the public interest for his firm to provide consulting services to Westchester Community College in connection with labor negotiations and related matters. This agreement will be tracked and monitored by College personnel.

Accordingly, approval of the annexed proposed Resolution is requested.
