WHEREAS, on May 9, 2018, two (2) bids were received and opened for Contract No. WCC-18-533 for Annual Electronic Fire Alarm System Inspection, Westchester Community College, Valhalla, New York; and

WHEREAS, the received bids were significantly over budget. The scope of the work will be adjusted to reflect budgetary constraints; and

WHEREAS, it is requested that all bids received for Contract No. WCC-18-533 be rejected and that Contract No. WCC-18-533 be re-advertised as Contract No. WCC-18-533-Rev for Annual Electronic Fire Alarm System Inspection, Westchester Community College Valhalla, New York

NOW, THEREFORE, BE IT

RESOLVED, that it is in the best interest of the County that all bids for Contract No. WCC-18-533, Annual Electronic Fire Alarm System Inspection, Westchester Community College, Valhalla, New York be and are hereby rejected and that Contract No. WCC-18-533 be re-advertised as Contract No. WCC-18-533-Rev for Annual Electronic Fire Alarm System Inspection, Westchester Community College, Valhalla, New York; and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be furnishing of a performance and payment bond in an amount equal to the first year's contract amount, in a form approved by the County Attorney. In substitution thereof, an annual, renewable performance and payment bond may be furnished, in an amount equal to that year's contract amount in a form approved by the County Attorney, so long as an annual bond remains in place, uninterrupted, for the duration of the contract. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570), and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Local Law No. 27-1997 of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
