On August 1, 2018, two (02) bids were received and opened for Contract No. 18-206 for Tibbetts Pavilion Replacement, Tibbetts Brook Park, Yonkers, New York.

Two (02) contractors submitted a bid for this project. The project was advertised on the Empire State Purchasing Group website, in addition to the Journal News (Westchester-Putnam Edition), and was viewed by 14 entities on the Empire State Purchasing Group website website. In addition, e-mails were sent to those 41 entities and to an additional 405 suppliers and contractors.

The bids were reviewed by the Department and it was determined that NUA Construction Corp. submitted the low bid in the amount of \$428,500.00.

The low bidder has been investigated and it has been found that NUA Construction Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade the existing pavilion.

This contract is in the public's best interest because it will promote the health and safety of the general public by improving the pavilion to meet current codes and standards.
