On November 7, 2018, eleven (11) bids were received and opened for Contract No. 17-507 for Various Paving and Drainage Improvements, North County Trailway, Saw Mill River Road to Westchester/Putnam Border, Westchester County, New York.

The bids were reviewed by the Department and it was determined that Peter J. Landi Inc. submitted the low bid in the amount of \$7,681,158.00.

The low bidder has been investigated and it has been found that Peter J. Landi Inc.:

- Performed satisfactory work in the past for the County.
