SUBJECT: Authority to amend an agreement with the YWCA of White Plains and Central Westchester to provide supervised visitation services by increasing the not-to-exceed amount by \$192.

On June 7, 2018, your Honorable Board approved a resolution authorizing the County of Westchester, acting by and through its Office for Women, (the "County") to enter into an agreement with the YWCA of White Plains and Central Westchester (the "YWCA") pursuant to which it will provide supervised visitation services, including facilitating orientations for those children who verbalize reluctance to visit with their non-custodial parent, and direct supervised visitation for families, for a term commencing on January 1, 2018 and continuing through December 31, 2020, for a total amount not-to-exceed exceed \$28,878 (the "Agreement"). The Agreement was subsequently executed.

Authority is now respectfully requested from your Honorable Board for the County to amend the Agreement by increasing the not-to-exceed amount by \$192, from an amount not-to-exceed \$28,878 to an amount not-to-exceed \$29,070. This additional funding will only be applied to the 2019 budget within the Agreement.

Except as specifically amended hereby, all other terms and conditions of the Agreement shall remain the same.

The proposed amendment will serve a public purpose by providing additional funding for the YWCA to offer a safe and secure environment during visits with a non-custodial parent.

The goal and objective of the proposed amendment is to provide additional funding for the YWCA to provide supervised visitation services, including facilitating orientations for those children who verbalize reluctance to visit with their non-custodial parent, and direct supervised visitation for families.

The goal and objective of the proposed amendment will be tracked and monitored by the Office for Women.

We respectfully recommend the adoption of the attached resolution.

RESOLUTION

Upon a communication from the Westchester County Executive and the Director of the Office for Women, be it hereby

RESOLVED, that the County of Westchester, acting by and through its Office for Women, (the "County") is hereby authorized to amend an agreement with the YWCA of White Plains and Central Westchester (the "YWCA") pursuant to which the YWCA will provide supervised visitation services, including facilitating orientations for those children who verbalize reluctance to visit with their non-custodial parent, and direct supervised visitation for families, for a term commencing on January 1, 2018 and continuing through December 31, 2020, for a total amount not-to-exceed exceed \$28,878 (the "Agreement"), in order to increase the not-to-exceed amount by \$192, from an amount not-to-exceed \$28,878 to an amount not-to-exceed \$29,070; and be it further

RESOLVED, that this additional funding will only be applied to the 2019 budget within the Agreement; and be it further

RESOLVED, that except as specifically amended hereby, all other terms and conditions of the Agreement shall remain the same; and be it further

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all documents and take any actions necessary to effectuate the purposes hereof.
