RE: Request for authority to enter into an Agreement with the State of New York, acting by and through the New York State Office for the Aging ("NYSOFA") to accept a grant in an amount not to exceed \$1,273,544, comprised of \$1,046,568 in State funds for the Wellness in Nutrition Program ("WIN") and \$226,976 in Federal funds for the Nutritional Services Incentive Program ("NSIP") to provide nutrition services to the elderly under the Older Americans Act, for the program period April 1, 2019 through March 31, 2020

The County of Westchester (the "County"), acting by and through its Department of Senior Programs and Services (the "Department"), seeks authority from your Honorable Board to enter into an agreement with the New York State Office for the Aging ("NYSOFA") to accept a grant for an amount not to exceed \$1,273,544, comprised of \$1,046,568 in State funds for the WIN program (formerly known as the Supplemental Nutrition Assistance Program ("SNAP")), and \$226,976 in Federal funds for the NSIP program, to provide nutrition services to the elderly under the Older Americans Act, for the program period April 1, 2019 through March 31, 2020 (the "Agreement").

It should be noted that \$279,792 in State funds will be used directly by the Department to provide nutrition counseling, nutrition education, service delivery activities as well as Area Agency Administration.

The County will administer the grant funds in accordance with the attached Schedule "A".

It should be noted that pursuant to Section 161.01 of the Laws of Westchester County, the inter-municipal agreements listed on Schedule "A" only require approval of the Westchester County Board of Legislators.

The Agreement does not constitute a procurement and as such, is not subject to the requirements of the Westchester County Procurement Policy.

I certify that my department, a.) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant

Terms”), b.) has reviewed the Grant Terms, c.) is aware of and understands all of the Grant Terms, and d.) can and will comply with all of the Grant Terms.
