On March 6, 2019 two (2) bids were received and opened for Contract No. 19-508 for Pier Reconstruction, Playland Park, Rye, New York.

Two (2) contractors submitted bids for this project. The project was advertised on the Empire State Purchasing Group website, in addition to the Journal News (Westchester-Putnam Edition), and was viewed by forty two (42) entities on the Empire State Purchasing Group website. In addition, e-mails were sent to those forty two (42) entities and to an additional five hundred ninety nine (599) suppliers and contractors.

The bids were reviewed by the Department and it was determined that Vinco Builders LLC submitted the low bid in the amount of \$449,342.80.

The low bidder has been investigated and it has been found that Vinco Builders LLC:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to reconstruct storm damaged portions of the Playland Pier.

This contract is in the public's best interest because it will promote the health and safety of the general public by maintaining the structural integrity of the Playland Pier.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 19-508 be awarded to Vinco Builders LLC in the amount of \$449,342.80.
