The 2019 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for rehabilitation of the Anita Lane utility bridge, which includes removal of existing wing wall and replacement of new concrete wing wall, installation of grouted rip-rap and repointing of stone masonry. This project also includes removal of a silt bar and installation of cofferdams for stream work.

The objective of this contract is to repair substandard structural elements of the bridge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Anita Lane utility bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
