Attached for your consideration is a resolution, which, if approved by your Honorable Board, would authorize the County of Westchester ("County"), acting by and through its Department of Environmental Facilities ("Department"), to solicit bids by public advertisement for the above referenced project. The work to be performed under this contract consists of furnishing labor and equipment required to perform internal video inspections of various County owned trunk and intercepting sewers and related work located in various municipalities within the North Yonkers Sewer District. This contract is subject to appropriations.

The goal and/or objective of this contract is to provide an internal inspection of the referenced sewers to inspect for potential structural and/ or operational defects and problems that may exist with the sewer pipe and related appurtenances. The work will be performed as part of the self assessment provision of the Federal Capacity, Management, Operations, and Maintenance (CMOM) program. This contract is deemed to fulfill a public purpose as the services provided under this Contract promotes the public health and welfare by insuring proper operation of the County's Trunk Sewer System and the prevention and/or elimination of any sewage overflows. The response and work are monitored by representatives of the Department throughout the contract to make sure all applicable regulations, safety precautions and codes regarding the protection of persons and property are adhered to and that a cost-effective project is the end product.
