The 2019 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for milling and resurfacing Main Street and Winter Hill Road. Additional work includes installing new curbs and sidewalks.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that these various roadways meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
