On August 14, 2019 the County of Westchester ("County") received and opened five (5) bids for Contract No. 19-517 for Synthetic Turf Field Replacement, Saxon Woods Park and Tibbetts Brook Park, Cities of White Plains and Yonkers, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that The LandTek Group, Inc. submitted the low bid in the amount of \$2,571,771.25.

The low bidder has been investigated and it has been found that The LandTek Group, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to restore the existing turf fields at Saxon Woods Park and Tibbetts Brook Park.
