The approval of four (4) subcontractors is being requested by Arben Group LLC, 175 Marble Avenue, Pleasantville, New York 10570 for the above referenced contract.

Tremson Corporation is being requested for Clearing and Grubbing Work. It should be noted that Arben Group LLC additionally canvassed five (5) MWOB firms for the Clearing and Grubbing Work; however, none of the five (5) firms responded to Arben Group LLC's inquiry.

Verde Electric Maintenance Corp. is being requested for Electrical Work. It should be noted that Arben Group LLC additionally canvassed eight (8) MWOB firms for the Electrical Work; however, three (3) firms expressed interest but failed to submit proposals within the allotted time frame; four (4) firms did not respond to Arben Group LLC's inquiry; and one (1) firm cannot accommodate the required contract schedule.

Safety Marking, Inc. is being requested for Line Striping Work. It should be noted that Arben Group LLC additionally canvassed four (4) MWOB firms for the Line Striping Work; however, none of the four (4) firms responded to Arben Group LLC's inquiry.

JP Hogan Coring & Sawing Corp., a WBE firm, is being requested for Saw Cutting and Coring Work. It should be noted that Arben Group LLC canvassed six additional MWOB firms for Saw Cutting and Coring Work; however, none of the other six (6) firms responded to Arben Group LLC's inquiry.

The listed subcontractors have been investigated, and the Department recommends approval.
