On September 18, 2019 the County of Westchester ("County") received and opened four (4) bids for Contract No. 19-501 for Rehabilitation of the Historic Carousel and Derby Racer, Playland Park, Rye, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Mace Contracting Corporation, a MBE firm, submitted the low bid in the amount of \$8,450,000.00, and has proposed the utilization of the following subcontractor: West-Fair Electric Contractors, Inc. (Electrical Work), 200 Brady Avenue, Hawthorne, New York 10532.

The low bidder has been investigated and it has been found that Mace Contracting Corporation:

The objective of this contract is to maintain the weather tightness and structural stability of the Carousel and Derby Racer pavilions.
