On December 11, 2019 the County of Westchester ("County") received and opened eight (8) bids for Contract No. 18-500 for Pavilion Playground Rehabilitation, Saxon Woods Park, Village of Scarsdale and City of White Plains, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Pat Corsetti, Inc. submitted the low bid in the amount of \$322,087.00.

The low bidder has been investigated and it has been found that Pat Corsetti, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade the existing pavilion playground.

It is my recommendation that Contract No. 18-500 be awarded to Pat Corsetti, Inc. in the amount of \$322,087.00.
