By Resolution approved on April 14, 2016 your Honorable Board awarded Contract No. 14-517 for Hurricane Sandy Rehabilitation – Phase II-2, Exterior Lighting and Electrical Rehabilitation, Yonkers Joint Wastewater Treatment Plant, Yonkers, New York to RLJ Electric Corp. in the amount of \$3,228,000.00, for the period from April 28, 2016 through October 27, 2019. The Contract was subsequently executed.

Contract completion has been delayed due to unforeseen field conditions. Therefore, the County of Westchester now seeks authority from your Honorable Board to amend the April 14, 2016 Resolution budget box end date from October 27, 2019 to December 31, 2021.

All other terms and conditions of the April 14, 2016 Resolution and the Contract shall remain in full force and effect and unchanged.
