SUBJECT: Resolution authorizing an amendment to the agreement between the County of Westchester and Human Development Services of Westchester, to provide funding for an Eviction/Foreclosure Program to assist residents of Westchester County in order to change the expiration date from December 31, 2019 to December 31, 2020.

On April 11, 2019, your Honorable Board approved a resolution authorizing the County of Westchester (the "County") to enter into an agreement with Human Development Services of Westchester, Inc. ("HDSW) to provide funding for an Eviction/Foreclosure Program in Westchester County. The not to exceed award amount is \$25,000.00 pursuant to an approved budget. The term of the agreement is January 1, 2019 to December 31, 2019.

The parties now desire to amend the above referenced agreement in order to extend the expiration date of the agreement from December 31, 2019 to December 31, 2020. The additional time is required in order for HDSW to meet their obligations as required in the agreement to provide services that will prevent evictions and foreclosures for middle to low income households in Westchester County.

The goal and objective of this agreement is to provide assistance to low to middle income households in order for them to remain in their homes. The program will be monitored by the Department of Planning staff, who will review the payment requests to make sure all contractual requirements are met.
