**RE**: Authority for the County of Westchester to consent to the assignment of an

agreement between the County and Barksdale Home Care Services Corp., as Assignor, to Supportive Home Care, LLC d/b/a Care365, as Assignee, for the purpose of providing consumer directed in-home services, and homemaker and housekeeper services to frail, homebound seniors under the Expanded In-Home

Services for the Elderly Program ("EISEP").

By resolution approved on June 6, 2019 (the "June 6<sup>th</sup> Resolution"), your Honorable Board authorized the County of Westchester (the "County"), acting by and through its Department of Senior Programs and Services (the "Department"), to enter into agreements with the ten (10) agencies listed in Schedule "A," attached to the June 6<sup>th</sup> Resolution (the "Agreements"), for the purpose of providing consumer directed in-home services and homemaker and housekeeper services to frail, homebound seniors under the EISEP Program, for the period from April 1, 2019 through March 31, 2020, payable at agreed-upon rates, not to exceed the aggregate sum of \$1,941,742. The Agreements have all been executed.

By letter dated November 4, 2019 (the "November 4<sup>th</sup> Letter"), the Department was notified by one of the ten (10) agencies, Barksdale Home Care Services Corp. ("Barksdale"), that Barksdale would be transferring its operations to a new owner, Supportive Home Care, LLC d/b/a Care365 ("Care365"), effective on or about December 31, 2019. The November 4<sup>th</sup> Letter further advised the Department that Barksdale's current staff, including personal care aides, home health aides, case coordinators, nurses and other management and support personnel will be working for Care365 and that Care365 would continue to provide services to the County without interruption.

Accordingly, authority is requested for the County to enter into an assignment agreement (the "Assignment Agreement") pursuant to which the County would consent to the assignment of its agreement with Barksdale (the "Agreement"), as Assignor, to Care365, as Assignee, for the purpose of providing consumer directed in-home services, and homemaker and housekeeper services to frail, homebound seniors under the EISEP Program for the period from April 1, 2019 through March 31, 2020, payable at agreed-upon rates, effective upon execution of the Assignment Agreement by all parties and approval of same by the Office of the Westchester County Attorney.
