RE: AUTHORITY TO ENTER INTO A LICENSE AGREEMENT WITH
TOLVE AMUSEMENTS, INC., 251 FOREST AVENUE, RYE, NEW
YORK 10580 TO OPERATE THE "LAKE BOATING" CONCESSION AT
PLAYLAND PARK FOR THE PERIOD MAY 1, 2020 THROUGH
SEPTEMBER 30, 2021.

Authority is requested of this Board for the County of Westchester ("County") to enter into a license agreement with Tolve Amusements, Inc., 251 Forest Avenue, Rye, New York 10580 to operate the "Lake Boating" concession at Playland Park, Rye, New York for the 2020-2021 operating seasons for the period of May 1, 2020 through September 30, 2021 to cover the 2020 and 2021 operating seasons, which run May through September of each year respectively.

As consideration for this license privilege, Tolve Amusements, Inc. will pay the County of Westchester a license fee of \$9,000 per operating season.

The goal and objective of this agreement is to increase County revenue while providing additional entertainment options for Playland patrons. This agreement allows patrons to enjoy a traditional entertainment option and generates excitement in the lake area. The objective of this agreement will be monitored using inspection and revenue reports.

The Westchester County Procurement Policy does not apply to concessions pursuant to Section 3(b) thereof, and, therefore, does not apply to this license agreement.

A Resolution is attached for your favorable consideration.

RESOLUTION

Upon a communication from the Commissioner of the Department of Parks, Recreation and Conservation, be it hereby

RESOLVED, that the County of Westchester (“County”) is authorized to enter into a license agreement with Tolve Amusements, Inc., 251 Forest Avenue, Rye, New York 10580 to operate the “Lake Boating” concession at Playland Park, Rye, New York for the 2020-2021 operating seasons for the period May 1, 2020 through September 30, 2021 to cover the 2020 and 2021 operating seasons, which run May through September of each year respectively; and be it further

RESOLVED, that for this license privilege, Tolve Amusements, Inc. will pay the County a license fee of \$9,000 per operating season; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby empowered to execute any and all instruments and take such other actions as may reasonably be necessary to effectuate the purposes thereof.
