RE: Authorization to enter into a Contract Amendment with the New York State Department of Health for the Childhood Lead Poisoning Primary Prevention Program Grant to extend the contract period and increase the not-to-exceed amount, pursuant to an approved budget, and to defend and indemnify the New York State Department of Health, as follows and described below:

On April 30, 2015, your Honorable Board approved a Resolution (the "April 30, 2015 Resolution") which authorized the County of Westchester ("County"), acting by and through its Department of Health ("WCDH"), to enter into a contract with the New York State Department of Health ("NYSDOH") to accept continued funding for the Childhood Lead Poisoning Primary Prevention Program Grant, pursuant to an approved budget, for the period 4/1/15 through 3/31/20, in the not-to-exceed amount of \$3,712,955. The original multi-year agreement has been executed.

The NYSDOH has sent notification that the period of the original multi-year agreement will be extended through 9/30/20 and additional funding in the amount not-to-exceed \$337,542 will be added to the original agreement amount.

Therefore, the WCDH now seeks authorization to enter into a contract amendment with the NYSDOH for the Childhood Lead Poisoning Primary Prevention Program Grant in order to extend the agreement period through 9/30/20 and increase the total amount not-to-exceed by \$337,542, pursuant to an approved budget, for the revised total amount not-to-exceed \$4,050,497.

The amendment will also require the County to indemnify the New York State Department of Health as follows:

"The Contractor shall be solely responsible and answerable in damages for any and all accidents and/or injuries to persons (including death) or property arising out of or related to the services to be rendered by the Contractor or its subcontractors pursuant to this Master Contract. The Contractor shall indemnify and hold harmless the State and its officers and employees from claims, suits, actions, damages and

cost of every nature arising out of the provision of services pursuant to the Master Contract.”

This contract promotes the public health and welfare of County residents through the identification of high risk housing units with lead paint hazards, the remediation of the hazards by property owners and the training/education of property owners in the safe abatement and remediation practices of lead hazards and risk factors.

The objective of the program is to preemptively identify these high-risk housing units and work with property owners to proactively prevent lead poisoning of children from occurring. Program goals include education on safe lead removal to ensure housing units are in compliance with housing code requirements.

WCDH continually monitors this program by tracking the number of housing units inspected for lead hazards, the number of hazards found and remediated, children ages six and under who have had prior lead screening or who need to be referred for screening, education and training to property owners and contractors in lead safe cleaning and work practices, and through the submission of quarterly reports to the NYSDOH. The total number of targeted housing units is 77,632.

The Contractor shall indemnify and hold harmless the State and its officers and employees from claims, suits, actions, damages and cost of every nature arising out of the provision of services pursuant to the Master Contract"; and, be it further

RESOLVED, that all other terms and conditions of the original agreement shall remain unchanged; and, be it further

RESOLVED that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute all appropriate contracts or documents necessary to effectuate the purposes of this resolution in the manner prescribed by law.
