SUBJECT: Authorization to extend the term of Short Form Agreement No. 18-804 with Alan Gassman, L.S. retroactively from April 14, 2020 until April 14, 2021

Authority of your Honorable Board is requested to extend the term of Short Form Agreement No. 18-804 (the "Agreement") between the County of Westchester (the "County") and Alan Gassman, L.S. (the "Consultant"), 225 Orchard Street, White Plains, New York 10604, for the provision of land surveying consulting services to various County departments retroactively from April 14, 2020 until April 14, 2021. The original Agreement was executed on April 15, 2018 and is for a total amount not to exceed \$20,000.00. The original Agreement completion date was April 14, 2019. By Resolution approved on May 9, 2019, your Honorable Board extended the term of the Agreement retroactively from April 14, 2019 until April 14, 2020.

The consulting services included in the original Agreement are in progress. The County has been satisfied with the quality of services provided to date. The services of the Consultant will be required beyond the original completion date in order to continue providing professional expertise required to provide parcel ownership and property line information to various County departments. Attached is a Resolution requesting an extension of the Agreement retroactively from April 14, 2020 until April 14, 2021 with no increase in the not to exceed amount of \$20,000.00.

The objective of this term extension is in the County's best interest as it will ensure that County projects are in conformance with all applicable land survey requirements.

Except as specifically amended hereby, all other terms and conditions of the Agreement will remain the same.

The Department of Public Works and Transportation will track scheduling and accomplishments by the Consultant and perform on-site inspections to ensure the successful completion of this project. It is recognized and understood that the County shall evaluate the performance of this contract by the Consultant and shall use such evaluation in deciding to award future contracts to the Consultant.

I urge your favorable consideration of the annexed proposed Resolution.
