On June 3, 2020 the County of Westchester ("County") received and opened nine (9) bids for Contract No. 18-529 for Playground Site Work Rehabilitation, Willson's Woods Park, City of Mount Vernon, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Pat Corsetti, Inc. submitted the low bid in the amount of \$410,390.50.

The low bidder has been investigated and it has been found that Pat Corsetti, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade the existing playground.

This contract is in the public's best interest because it will promote the health and safety of the general public by improving the playground to meet current State and Health Department codes and standards.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 18-529 be awarded to Pat Corsetti, Inc. in the amount of \$410,390.50.
