SUBJECT: Resolution authorizing an amendment to the agreement between the County of Westchester and the Town of Greenburgh for an Old Tarrytown Road/Manhattan Avenue/Knollwood Road Sidewalk project in the Town of Greenburgh, in order to change the contract period from March 1, 2020 - May 31, 2021 to July 15, 2020 – June 14, 2021.

On March 5, 2020, your Honorable Board approved a resolution authorizing the County of Westchester to enter into an agreement (“Agreement”) with the Town of Greenburgh for a Sidewalk project on Old Tarrytown Road/Manhattan Avenue/Knollwood Road in the Town of Greenburgh (the “Town”). The amount of the grant is \$200,000, pursuant to an approved budget, and the term of the agreement is March 1, 2020 to May 31, 2021.

The parties now desire to amend the agreement in order to change the contract period from March 1, 2020 - May 31, 2021 to July 15, 2020 – June 14, 2021 in order to be in compliance with all of HUD’s requirements. All other terms and conditions of the Agreement will remain the same.

The goal and objective of the agreement is to ensure the safety of the public by constructing sidewalks to allow pedestrians a safe walkway in the Town of Greenburgh. The project will be monitored by the Department of Planning staff, who will make site visits during construction to ensure all contractual requirements are met.

This procurement is in compliance with the County of Westchester Procurement Policy Procedures, pursuant to Section 3(a)xvi, which states that contracts with recipients for disbursement of grants or loans under the Community Development Block Grant Program are exempt.

Act # 37-2019, adopted March 11, 2019, by the Westchester County Board of Legislators, authorized the County to submit an Urban County Application under the Federal Community Development Block Grant, Emergency Solutions Grant, and HOME Programs, including a FY 2019-2023 Consolidated Plan and to accept such Grants.

On May 30, 2019, the Board of Acquisition and Contract approved a resolution authorizing the County of Westchester to enter into an agreement with the United States Department of Housing and Urban Development (HUD) to accept a grant totaling \$3,544,891 in Community Development Block Grant (CDBG) funds.

I recommend approval of this amendment.
