SUBJECT: Authority to rescind the Resolution approved on June 6, 2020 consenting to the assignment of Contract 16-206, dated May 23, 2017, from Cascade Water Services, Inc. to Nalco Company LLC and instead approve amending Contract 16-206 to change the name of the Contractor from Cascade Water Treatment Services, Inc. to Nalco Company, Inc. (F/K/A Cascade Water Treatment Services, Inc.) and for Nalco to assume all duties and obligations of Cascade, and authorize the County exercise its option to renew Contract 16-206 for an additional two (2) year renewal period from June 1, 2020 to May 31, 2022; and increase the amount of Contract 16-206 by \$237,050.00 from \$355,575.00 to a new total not to exceed of \$592,625.00.

By a resolution approved on June 6, 2020 (the “June 6th Resolution”), your Honorable Board authorized the County of Westchester (the “County”), acting by and through its Department of Public Works and Transportation (the “Department”), to: (1) consent to the assignment of Contract No. 16-206, dated May 23, 2017, for Countywide Water Treatment Services, Westchester County, New York (“Contract No. 16-206”) from Cascade Water Treatment Services, Inc. (“Cascade”) to Nalco Company LLC (“Nalco”), (2) exercise its option to renew Contract 16-206 for a two (2) year renewal term commencing on June 1, 2020 and terminating on May 31, 2022, and (3) increase the amount of Contract 16-206 by \$237,050.00 from an amount of \$355,575.00 to a new amount not to exceed \$592,625.

After the approval of the June 6th Resolution, Nalco informed the County that, due to the fact that Nalco acquired and merged Cascade into Nalco, consent is sought to change the name of Cascade to Nalco Company LLC (F/K/A Cascade Water Services, Inc.) and for Nalco to assume all right, interest, privileges, duties and obligations of performance under the Contract No. 16-206.

Therefore, authorization is now sought from your Honorable Board to rescind the June 6th Resolution and approve amending Contract 16-206 to change the name of the Contractor from Cascade Water Treatment Services, Inc. to Nalco Company LLC (F/K/A Cascade Water Treatment Services, Inc.) and for Nalco to assume all right, interest, privileges, duties and obligations of performance under the Contract No. 16-206.

Authorization is also sought for the County to exercise its option to renew Contract 16-206 for an additional two (2) year renewal period from June 1, 2020 to May 31, 2022 and increase the amount of Contract 16-206 by \$237,050.00 from \$355,575.00 to a new total not to exceed of \$592,625.00.

Contract 16-206 is in the public's best interest because it will promote the health and safety of the general public by preventing bacterial growth and corrosion of the systems using environmentally friendly chemicals and will reduce the County's annual maintenance costs.

Accordingly, I most respectfully recommend the adoption of the annexed proposed Resolution.

RESOLVED, that the resolution approved on June 6, 2020 authorizing the assignment of Contract No. 16-206, dated May 23, 2017, for Countywide Water Treatment Services, Westchester County, New York from Cascade Water Treatment Services, Inc. (“Cascade”) to Nalco Company LLC, is hereby rescinded; and be it further

RESOLVED, that the County of Westchester (the “County”), acting by and through its Department of Public Works and Transportation (the “Department”), is authorized to amend Contract 16-206 to change the name of the Contractor from Cascade Water Treatment Services, Inc. to Nalco Company LLC (F/K/A Cascade Water Treatment Services, Inc.), and consent to Nalco Company LLC assuming all right, interest, privileges, duties and obligations of performance under the Contract No. 16-206; and be it further

RESOLVED, that the County is authorized to exercise its option to renew Contract 16-206 for an additional two (2) year renewal period from June 1, 2020 to May 31, 2022; and be it further

RESOLVED, that the County is authorized increase the amount of Contract 16-206 by \$237,050.00 from an amount of \$355,575.00 to a new total not to exceed of \$592,625.00; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute and deliver any documents and take all actions necessary or appropriate to effectuate the purposes hereof
