SUBJECT: Authority to amend an agreement with the YWCA White Plains & Central Westchester Inc. to provide childcare services by increasing the not-to-exceed amount by \$3,128.00.

On April 2, 2020, your Honorable Board approved a resolution authorizing the County of Westchester, acting by and through its Office for Women, (the "County") to enter into an agreement with the YWCA White Plains & Central Westchester Inc. (the "YWCA"), pursuant to which it will provide child care in the Richard A. Daronco Court House in White Plains through its Children's Center, for a term commencing on January 1, 2020 and continuing through December 31, 2020, for an amount not to exceed \$64,441.00 (the "Agreement"). The Agreement was subsequently executed.

On June 11, 2020, your Honorable Board approved a resolution authorizing the County to amend the Agreement by expanding the scope of services to include additional childcare services for children of essential and non-essential workers in Westchester (the "First Amendment"). The First Amendment was subsequently executed.

Authority is now respectfully requested from your Honorable Board for the County to amend the Agreement once again by increasing the not-to-exceed amount by \$3,128.00, from an amount not-to-exceed \$64,441.00 to an amount not-to-exceed \$67,569.00 (the "Second Amendment"). This additional funding will only be applied to the 2020 budget within the Agreement.

Except as specifically amended hereby, all other terms and conditions of the Agreement shall remain the same.

The proposed Second Amendment will serve a public purpose by providing additional funding for the YWCA to make available childcare services in the Richard A. Daronco Court House in White Plains as well as for children of essential and non-essential workers in Westchester.

The goal and objective of the proposed Second Amendment is to provide additional funding for the YWCA to provide childcare services in the Richard A. Daronco Court House in White Plains as well as for children of essential and non-essential workers in Westchester.

The goal and objective of the proposed Second Amendment will be tracked and monitored by the Office for Women.

I respectfully recommend the adoption of the attached resolution.

RESOLUTION

RESOLVED, that the County of Westchester, acting by and through its Office for Women, is hereby authorized to amend an agreement with the YWCA White Plains & Central Westchester Inc. Daronco Court House in White Plains as well as for children of essential and non-essential workers in Westchester, for a term commencing on January 1, 2020 and continuing through December 31, 2020, for an amount not to exceed \$64,441.00 (the "Agreement"), in order to increase the not-to-exceed amount by \$3,128.00, from an amount not-to-exceed \$64,441.00 to an amount not-to-exceed \$67,569.00; and be it further

RESOLVED, that except as specifically amended hereby, all other terms and conditions of the Agreement shall remain the same; and be it further

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all documents and take any actions necessary to effectuate the purposes hereof.
