The work under this contract consists of providing all necessary labor, material and equipment required for the infrastructure improvements of Tibbetts Brook Park, which includes resurface, modify and reconstruct the main park access drive; reconstruction and resurfacing of access driveway through park; construction of expanded parking facilities, including ADA, parking areas along with associated drainage, landscape and other site improvements. The existing gate house will be removed and replaced and the park pathways will be resurfaced.

The objective of this contract is to upgrade the infrastructure of Tibbetts Brook Park.

This contract is in the public's best interest because it will promote the health and safety of the general public by improving the infrastructure of the park to meet current codes and standards.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
