On January 6, 2021 the County of Westchester ("County") received and opened thirteen (13) bids for Contract No. 18-531 for Playground Site Work Rehabilitation, Kensico Dam Plaza, Mt. Pleasant and North Castle, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that R. Pagni & Sons, Inc., submitted the low bid in the amount of \$1,299,831.31, and has proposed the utilization of the following subcontractor: Naber Electric Corp., 1025 Saw Mill River Road, Yonkers, New York 10710.

The low bidder has been investigated and it has been found that R. Pagni & Sons, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade the existing playground.

This contract is in the public's best interest because it will promote the health and safety of the general public by improving the playground to meet current State and Health Department codes and standards.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 18-531 be awarded to R. Pagni & Sons, Inc. in the amount of \$1,299,831.31.
